Yarpole 1841:

The Tithe Commutation Act was passed in 1836, following years of complaint by farmers who had to pay one tenth of their produce to support the Church. The Act allowed for a payment in money rather than in produce, and in order to work out who should pay what, tithe Commissioners collected information on every field subject to tithe.

The Commissioners needed to know who owned the field, who was the tenant, what was grown, what it was worth and what the tithe payment would be in cash terms. All this information was called 'The Apportionment', and accompanied the actual Tithe Map. These documents date to the period 1838 to 1845, and, for Herefordshire, are held at the County Record Office.

For the purpose of this Article, the portion of the Tithe Map, covering the centre of Yarpole, was re-traced from a copy of the original Tithe Map, to identify those numbered plots in which there was a property; each plot was cross-referenced with the relevant entry in the Apportionment which gave the names of the landowner and tenant, and, in the case of properties, 'tenant' has been equated to 'occupier'.


Of the 28 properties identified on the Map (see overleaf), five were 'in hand' i.e. either occupied by the landowner or waiting for a tenant, one was 'void' i.e. not occupied, and 18 were occupied by named tenants, 17 of them were cross-matched with names in the 1841 census; the one exception (plot 636) could be explained by a change in tenancy between the time when the 'Apportionment' was compiled and the census.

The remaining four properties (two of which are farms and two are linked cottages) were all 'tenanted' by a William Taylor who may have sublet some of these properties or may have been acting as an 'Agent'.

This data is set out on page three of this Article and gives an historical snap-shot of the identified properties.

The coloured map on page four of this Article gives an over-view of the distribution of land ownership, in 1841, in the area of the map.


